BYLAW NO. 5516

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish fees and charges for the South Cariboo Regional Airport.

The Board of the Cariboo Regional District, in open meeting assembled, enacts as follows:

1. CITATION:

This bylaw may be cited for all purposes as “South Cariboo Regional Airport Fees and Charges Bylaw No. 5516, 2025”.

2. FEES AND CHARGES:

The Cariboo Regional District hereby establishes fees and charges for aircraft landings, aircraft and helicopter parking, vehicle parking, hangar licence fees, and fees for lease of land under agreement at the South Cariboo Regional Airport. Schedule “A”, attached to and forming part of this bylaw, establishes the landing fees, aircraft and helicopter parking fees, vehicle parking fees, hangar licence fees, and fees for lease of land under agreement the airport to be charged.

3. REPEAL

“South Cariboo Regional Airport Fees and Charges Bylaw No. 5397, 2022” is hereby repealed.

**SOUTH CARIBOO REGIONAL AIRPORT
FEES AND CHARGES***

Landing Fees

These fees, which apply to commercial aircraft landing at the South Cariboo Regional Airport, are established at \$15.00 per landing of rotary-wing operations and \$30.00 per landing of fixed-wing operations.

Aircraft and Helicopter Parking

Daily rate: \$7.50
Monthly rate: \$50
Six-month rate: \$240
Annual rate: \$360

Vehicle Parking

Only vehicles related to airport use may be parked at the Airport.

Monthly rate: \$30

Other

The Region also has established an annual Private Hangar licence rate of \$1,000 base fee plus \$4.00 per square meter of the hangar footprint.

The Region also established an annual bare land license rate of \$1,000 base fee plus \$1.93 per square meter for licence of land under agreement. The base fee shall only apply once per private hangar agreement for those with land and a hangar building on the property.

* Applicable taxes will be in addition to the fees charged.
