BYLAW NO. 5513

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to amend the "150 Mile House Fire Protection Service Establishment Bylaw No. 3897, 2004".

The Board of Directors of the Cariboo Regional District, duly assembled, hereby enacts as follows:

1. CITATION

A) This bylaw may be cited for all purposes as the "150 Mile House Fire Protection Service Amendment Bylaw No. 5513, 2025".

2. AMENDMENTS

A) That sections 2 and 3 of Bylaw No. 3897, 2004 are deleted in their entirety and replaced by the following:

"2. SERVICE CONVERSION

- A) The fire protection service provided within the specified area created under Bylaw 1418 is hereby established as the 150 Mile House Fire Protection Service to provide fire protection within the service area."
- B) That section 4 of Bylaw No. 3897, 2004 is deleted in its entirety and replaced by the following:

"4. SERVICE AREA

- A) Schedule A, attached to and forming part of this bylaw, indicates the boundaries of the 150 Mile House Fire Protection Service Area. "
- C) That section 6 of Bylaw No. 3897, 2004 is deleted in its entirety and replaced by the following:

"6. COST RECOVERY

- i) Property value taxes imposed in accordance with the *Local Government Act;*
- ii) Parcel taxes imposed in accordance with the Local Government Act;
- iii) Fees and charges imposed in accordance with the Local Government Act;
- iv) Revenues raised by other means authorized by the *Local Government Act* or other Act;
- v) Revenues received by way of agreement, enterprise, gift, grant or otherwise.
- B) The maximum amount that may be requisitioned annually for the service shall not exceed the greater of \$550,000 or an amount determined by applying a rate of \$1.36/1,000 to the net taxable value of land and improvements within the service area."
- D) That all Schedule "B"s attached to and forming part of Bylaw No. 3897, 2004 are hereby deleted.
