



**CARIBOO REGIONAL DISTRICT
BYLAW NO. 5568**

A bylaw of the Cariboo Regional District in the Province of British Columbia to determine fees and procedural regulations for map creation and delivery.

The Board of Directors of the Cariboo Regional District enacts as follows:

TITLE

(1) This bylaw may be cited as the “Map Services and Fees Bylaw No. 5568, 2026”.

DEFINITIONS:

(2) For the purpose of this bylaw, the following terms are defined as follows:

- (a) “Custom Mapping Time” means time spent by any Mapper in the creation of a Map. Moreover, it includes any computer processing time, including but not limited to geoprocessing and file transfer time.
- (b) “Lot Plan” means a Map laid out and/or printed in letter size which outlines one or more parcels, not dimensioned and used as an illustrative reference only.
- (c) “Manager” means an employee or contractor of the Cariboo Regional District whose job description includes a managerial or supervisory role or roles.
- (d) “Mapper” means any employee or contractor of the Cariboo Regional District whose job description includes the provision of Map preparation services.
- (e) “Map” means any digital or hard copy representation of a geographical area highlighting relationships between elements of that space such as objects, regions, and themes.

SCOPE

(3) This bylaw applies to any external request submitted pursuant to this bylaw for Map services by any Mapper.

MAP SERVICES AND FEES:

(4) All requests for Maps:

(a) greater than 1,290.32 sq cm (200 sq in); and/or

(b) requiring custom mapping time

are required to be first approved by a Manager.

(5) The Cariboo Regional District reserves the right to deny or delay the creation or delivery of any Map.

(6) The Map requestor shall pay the Cariboo Regional District or put on account the service fee in the amount prescribed in the Fee Schedule attached hereto as Schedule A, forming part of this bylaw, prior to delivery.

(7) The Cariboo Regional District reserves the right to request a deposit of up to 50% of the estimated cost of Map preparation at the time of Map request submission.

REPEAL:

(8) "Cariboo Regional District Map Services and Fees Bylaw No. 4655, 2010" is repealed.
