

# **CARIBOO REGIONAL DISTRICT**

## **BYLAW NO. 5470**

A bylaw of the Cariboo Regional District, in the Province of British Columbia, to establish a service for the contribution of funds to the Community Halls in Electoral Area J.

WHEREAS, the Board of the Cariboo Regional District has deemed it in the best interest of the Regional District to contribute to the Community Halls in Electoral Area J without taking any role in or responsibility for the operation of the services; and,

WHEREAS, the Board of the Cariboo Regional District has obtained the approval of the service area electors by the Alternative Approval Process in accordance with the *Local Government Act*;

NOW THEREFORE, the Board of the Cariboo Regional District, duly assembled in an open meeting, enacts as follows:

#### 1. <u>Establishment and Citation</u>

- a) The Cariboo Regional District hereby establishes within Electoral Area J a community hall service which shall be known as the "Electoral Area J Community Hall Support Service". The sole purpose of this service is to allow for contribution of funds for costs associated with ownership and operation of the Community Halls within Electoral Area J.
- b) This bylaw may be cited for all purposes as "Cariboo Regional District Electoral Area J Community Hall Support Service Establishment Bylaw No. 5470, 2024".

#### 2. <u>Service Area and Participants</u>

- a) The boundaries of Electoral Area J shall determine the Electoral Area J Community Hall Support Service Area.
- b) The participant of the Electoral Area J Community Hall Support Service shall be Electoral Area J.

### 3. <u>Cost Recovery</u>

- (a) The annual operating costs for the service shall be recovered by one or more of the following:
  - 1. property value taxes imposed in accordance with Division 3 [Requisition and Tax Collection] of the *Local Government Act;*
  - 2. the requisition of money to be collected by parcel taxes imposed in accordance with Division 3;
  - 3. revenues raised by other means authorized by the *Local Government Act* or another Act; and/or
  - 4. revenues raised by way of agreement, enterprise, gift, grant or otherwise.
- (b) The maximum amount of money that may be requisitioned in any one year for the service provided in Section 1 of this bylaw shall not exceed the greater of \$30,000 or an amount raised by applying a tax rate of \$0.1394 per \$1,000 to the net taxable value of land and improvements in the Service Area.
